To Whom It May Concern,

Thomson Research Associates, Inc. (hereafter referred to as "TRA") is committed to supporting our customers. To this end, TRA partners with our suppliers to ensure that our Ultra-Fresh products are compliant with both REACH legislation and the Biocidal Products Regulation (BPR).

For Ultra-Fresh products sold in Europe, all *active ingredients* are exempt from REACH as they are legislated by the BPR. TRA and our suppliers ensure that the *active ingredients* used are included on Annex 1.

As for *the inert (or auxiliary) ingredients* in Ultra-Fresh products, TRA sources these from suppliers within the EU who have registered these ingredients as required under REACH. Therefore, these substances are also in full compliance with the REACH legislation.

Re: Regulatory Status of Ultra-Fresh DW-30

To Whom It May Concern,

On behalf of Thomson Research Associates, Inc., I can confirm that the product Ultra-Fresh DW-30 is registered with the US Environmental Protection Agency (US EPA) under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA) as an antimicrobial designed to control the growth of fungi, bacteria and algae in polyurethane foams, rubber, non-aqueous coatings, adhesives, PVC and grout mortar and mastics. The registration number is 92760-9.

I can also confirm that the product complies with the EU Biocidal Products Regulation (BPR) EU 528/2012. The active substances and suppliers are listed on the Article 95 List for use in the following Product Types:

Active Ingredient/Product	Product Type
Thiabendazole (TBD)	7, 8, 9, 10
Zinc pyrithione (ZPT)	2, 6, 7, 9, 10, 21
Ultra-Fresh DW-30 containing TBD and ZPT	7, 9, 10

None of the ingredients in Ultra-Fresh DW-30 appear on the Substances of Very High Concern (SVHC) list or Manufacturing Restricted Substances List (RSL). None of the ingredients in Ultra-Fresh DW-30 appear on the American Apparel & Footwear Association's Restricted Substances List (RSL) 19th Edition, as published in February 2018.

Ultra-Fresh DW-30 also is listed on the OEKO-TEX® list of Products with Biological Activity as an Auxiliary for Biological Active Finish, registered to Thomson Research Associates.
