The products have been tested preparing a <u>hypothesis of an upholstered</u> piece of furniture mock up whose construction is reported in the table below for each products:

Side exposed: indicated by the Sponsor (front of the fabric, inside of the piece).

The sampling of the fabrics has been effected by the Sponsor c/o the factory of ABITEX S.r.I. located in Via del Cristo, 84 - 33044 Manzano (UD), on 27th September 2024.

The product has been tested using the prescriptions reported in IMO Res. MSC. 307(88) - (2010 FTP Code) Annex (Part Appendix 3 Point 1 as recalled for Item MED/3.20c.

Applications/Limitations

The compliance is valid provided the following conditions are observed:

- For each product, the composition, the weight and all the technical data must remain the same as the ones subjected to this examination.
 - In particular the composition may range from a minimum of 52% to a maximum of 90% of recycled polyester, the remaining part being on any case made in polyester and the weight may range from a minimum of 430 g/m 2 to a maximum of 730 g/m 2 .
- For each product, the composition of the actual upholstered piece of furniture must be the same as the one tested.

Moreover, it is valid only for the following products of the B-GREEN GRS (collection) in object:

B-GREEN GRS GROVIGLIO - B-GREEN GRS REPS; B-GREEN GRS STRUTTURA; B-GREEN GRS PANAMA; B-GREEN GRS RETE; B-GREEN GRS BOUCLE'

Moreover according to Directive 2014/90/EU, Annex II Paragraph 3, a project examination and a risk evaluation have been carried out. Concerning this aspect, the Sponsor has declared that the applicable standard cover all the reasonable risk that can be foreseen. This Notified Body maintains such a declaration in the files relative to the product object of this EC Type Examination.

It is reminded that the present document refers to hypothesis of upholstered furniture, obtained coupling the fabrics supplied by the Sponsor with the foam supplied by the Laboratory.

In case the filling materials is changed from the one used for this examination, the test shall be repeated with the actual combination used.
